7.3 Financial Proposal

The financial proposal should contain the following documents in one cover (folder),i.e. Bill of Quantities (BOQ). The Contractor is to quote the rate (percentage above / below or AT PART) on line through computer in the space marked for quoting rate in the BOQ only. In case, quoting any rate in Tender Form-1 i.e. Form No. 2911, the tender is liable to be summarily rejected. Only download copies of the above documents are to be uploaded virus scanned and digitally signed by the contractor.

7.4 Eligibility Criteria

Contractor having Work Orders with Completion Certificates of executing at least one-third value (completed value of work considering percentage above / below or AT PAR) of similar nature of work in a single contract (during last 5 years from the date of this NIT),

Such certificates are to be issued by an official not below the rank of Executive Engineer/Divisional Engineer/ District Engineer/Project Manager/Executive Officer/Chairman, as the case may be.

7.4.2 Penalty for suppression / distortion of facts

If any tenderer fails to produce the original hard copies of the documents (especially Completion Certificates and audited balance sheets), or any other documents on demand of the Tender Evaluation Committee within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the tenderer will be suspended from participating in the tenders on e-Tender platform for a period as will be decided by the competent Authority. In addition, his user ID will be deactivated and Earnest Money Deposit will stand forfeited.

7.5 Taxes & duties to be borne by the Contractor

8. Opening and evaluation of tender

8.1 **Opening of Technical Proposal**

- i. Technical proposals will be opened by the **Principal, Raja Narendra Lal Khan Women's College (Autonomous), Midnapore** and / or his authorised representatives electronically from the website stated in Clause 3, using their Digital Signature Certificate.
- ii. Intending tenderers may remain present if they so desire.
- iii. Cover (Folder) for Statutory Documents (vide Clause 7.2.a) should be opened first and if found in order, Cover (Folder) for Non-statutory Documents (vide Paragraph 7.2.b) will be opened. If there is any deficiency in the Statutory Documents, the tender will summarily be rejected.
- iv. Decrypted (transformed into readable formats) documents of the Non-statutory Cover will be downloaded, and handed over to the Tender Accepting Authority.

8.2 Uploading of summary list of technically qualified tenderers (1st round)

- i. Pursuant to scrutiny and decision of the Technical Accepting Authority, the summary list of eligible tenderers and the serial number of work(s) for which their Financial Proposals will be considered will be uploaded in the website www.rnlkwc.ac.in. No individual intimation will be given
- Ii While evaluation, the Tender Accepting Authority may summon the tenderers and seek clarification / information or additional documents or original hard copy of any of the documents already submitted and if these cannot be produced within the stipulated time frame, their proposals will be liable for rejection.

8.3 Opening and evaluation of Financial Proposal

- i. Financial proposals of the tenderers declared technically eligible by the Tender Accepting Authority will be opened electronically from the web portal stated in Clause 3 on the prescribed date, by the Principal, Raja Narendra Lal Khan Women's College (Autonomous), Midnapore and / or his authorised representatives.
- ii. The encrypted copies will be decrypted and the rates will be read out to the contractors remaining present at that time.
- iii. After evaluation of Financial Proposal by the Tender Accepting Authority, Principal, Raja Narendra Lal Khan Women's College (Autonomous), may upload the final summary result containing inter- alia, name of contractors and the rates quoted by them against each work provided it is satisfied that the rate obtained is fair and reasonable and there is no scope of further lowering down of rate.
- iv. However, if there is any scope for lowering down of rates in the opinion of the, Tender Accepting Authority, it may be chosen to declare the former publication stated in above as semi-final and notify all the tenderers through the website to attend sealed bids to be followed by open bids to be held at his office at prescribed date and time, which will be done offline, i.e. as manually, as per present procedure.

8.4 Procedures to be followed when one / two technically qualified tenderers participated in any tender.

- a. Normally, financial bid of technically qualified single/two tenders shall not be accepted in the first instance. In that case the financial bid(s) shall not be opened and the tender process shall be dropped. A fresh notice inviting tenders (2nd call) shall be issued and the procedure shall have to be followed by the intending bidders afresh.
- b. Notification no. 925-F(Y) dated 14.02.2017 of Finance Department, Audit Branch, Govt. Of W.B.will follow for acceptance of L1 / H1 bid / Single bid when the no. of qualified bidders during 2nd call is less than three.

9. Acceptance of Tender

- I. Lowest valid rate should normally be accepted. However, the Tender Accepting Authority does not bind himself to do so and reserves the right to reject any or all the tenders, for valid reasons and also reserves the right to distribute the work amongst more than one tenderer.
- II. During the entire process of the tender, if it is found that any penal measures imposed by any Govt/Semi-Govt. Deptt/Autonomous body against any intending tenderer, the Authority reserves the right to reject any bid offered by the said tenderer.

10. Payment

Payment of the bill will be made through by crossed account payee Cheque or electronic payment (NEFT) or ePFMS portal by Print Payment Advices only after completion of scheduled work after deduction of 10% normal security & 5% performance security or submission of bank guarantee and others taxes as per Govt. Norms. Security deposit & performance security is refundable after 1 (one) year subject to the condition of successful running of the items.

- 11. Bid validity: The Bid will be valid for 120 days from the date of opening of the Financial Bid. If the bidder withdraws the bid during the period of bid validity the earnest money as deposited will be forfeited forthwith without assigning any reason thereof. In connection with the work, Arbitration will not be allowed.
- 12. All the Prospective Bidders shall have to execute the work in such a manner so that

appropriate service level of the work is kept during progress of work to the successful completion of the work to the entire satisfaction of the Authority may be considered towards release of full "Security Deposit".

- 13. Special Security Deposit: Retention towards Performance Security amounting to 5(Five) percent of the billed amount shall be made by the site engineer or authorised representative from 1st R.A. bill to Final bill. No interest would be paid on the Performance Security Deposit.
- 14. The tender will be on the basis of Turnkey project and the contractors are to quote their rate for Civil works & Electro- Mechanical works which will apply to all the indicated bill of Items of Civil & Electro-Mechanical works in the Tender Schedule irrespective of quantities i.e. all the items as shown in the schedule will be applicable to this tender. In analysing the rates for supplementary items, if found necessary and which are not covered by this Schedule of item and rates, the principles as laid down in clause 12 of the tender form in Form-1 [W.B.F. 2911(ii)] in which the contract will be executed, shall be followed.
- 3. The acceptance of the tender will rest with the competent authority without assigning reason thereof. The accepting authority reserves right to reject any or all tenders without assigning any reason thereof.
- 4. The Tenderer shall have to comply with the provisions of (a) Contract labour (Regulation & abolition) Rules, 1970 (b) Minimum Wages Act 1948 or the modification thereof or any other laws relating thereto as will be in force from time to time.
- 5. Department shall not entertain any claim whatsoever from the contractor for payment of compensation on account of idle labour on any ground including non-possession of land.
- 6. The Department shall not be held liable for any compensation due to machines becoming idle for any circumstances including untimely rains, other natural calamities, strike etc.
- 7. For price preference, if applicable to W.B. Govt. Undertakings, the intending tenderers shall produce attested copies of the G.O.'s in favour of respective undertakings along with their application. Otherwise their claim will not be entertained in any case.

- 15. No mobilization / secured advance will be allowed.
- 16. That, no price escalation will be entertained in any case till completion of the project.
- 17. GST/Sales Tax, Cess, Royalty of sand, stone chips, stone metal gravel, boulders, forest product etc, Toll Tax, Income Tax, Ferry Charges and other Local Taxes if any are to be paid by the contractor.
